

2018 Mid Week MTB Race Series Agreement

Read the following and initial that you have read and understand the 2018 Mid Week MTB Race Series terms.

Racing: I agree to that I have read and understand the Mid Week MTB Racer Handbook. I will wear a helmet at all times during the race. I agree to yield to a passing rider, provided that the passing riders are vocal when overtaking me. I will not intentionally impede another racer's progress. Electric bikes (E-Bikes) are not permitted in the Mid Week MTB Series. *Unsportsmanlike behavior and-or use of profane or abusive language will not be tolerated. Short cutting of a race course results in a DQ. At the sole discretion of the Race Director, racers may be issued a warning or disqualified for a violation of any stated rules.

Registration: Racers must register, pay designated entry fees, sign all appropriate waivers, and display the assigned race plate on their bicycle to participate in any Mid Week MTB Race. I agree to use the issued race plate (\$10 one-time purchase) for all races, if I lose my number plate I understand I am subject to a \$15 replacement fee. I give Bike Utah and the Mid Week MTB Series permission to use my photographic likeness for marketing purposes - (ie. use of photos taken during race).

Race Divisions: I agree to let the race director use discretion regarding mandatory race category changes during the 2018 season. I am solely responsible for knowing which race division I am competing in and its start time.

Series Points: I understand if I changed race divisions during the season my point total may vary / or may lose points depending on the category move. Cross country and mini enduros are two separate series and points do not carry over to the other discipline.

Cancellation Policy: In cases of adverse weather, adverse trail conditions, or unforeseen circumstances, the race organizers reserve the right to any of the following actions:- delay start- shorten race-move the start or finish- reschedule the race- cancel the race, announcements. If a race is cancelled due to weather, racers who have paid will receive a series credit for the 2018 season and we will attempt to reschedule the race.

Result Conflicts: Race result conflicts will be accepted by race director until the end of the next business day following a race. Race results will be final after 24 hours after the completion of the race.

ACCIDENT WAIVER AND RELEASE OF LIABILITY

I acknowledge that the Mid Week Mountain Bike Race Series is an athletic event and an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, lack of hydration, weather, condition of athletes, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event. These risks are not only inherent to athletics, but are also present for volunteers. I hereby assume all of the risks of participating and/or volunteering in the Mid Week Mountain Bike Race Series. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently trained for participation in the event and have not been advised otherwise by a qualified medical person.

I acknowledge that this Accident Waiver and Release of Liability form will be used by Bike Utah, the Mid Week MTB Series, Utah Valley University, Wasatch County, Jordanelle Ridge, RE Investment Holdings, Park City Municipal Corporation, Draper City, DeJoria Center, Kamas City, Solitude Mountain Resort, Snowbird Resort LLC and Affiliates, and all other sponsors or entities which may participate and that it will govern my actions and responsibilities at the Mid Week Mountain Bike Race Series.

In consideration of my application and permitting me to participate in the Mid Week Mountain Bike Race Series, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me including my traveling to and from this event,

THE FOLLOWING ENTITIES OR PERSONS:

Their directors, officers, employees, volunteers, representatives, and agents, the event holders, event sponsors, event volunteers, and landowners; (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this event, whether cause by the negligence of releases or otherwise.

I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident, and/or illness during the Mid Week Mountain Bike Race Series.

I understand that at the Mid Week Mountain Bike Race Series or related activities, I may be photographed. I agree to all my photo, video or film, likeness to be used for any legitimate purpose by Bike Utah, Mid Week MTB Series, Utah Valley University, Wasatch County, Jordanelle Ridge, RE Investment Holdings, Park City Municipal Corporation, Draper City, DeJoria Center, Kamas City, Solitude Mountain Resort, Snowbird Resort LLC and Affiliates, and all other sponsors and assigns.

The Accident Waiver and Release of Liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
